The Opening of the Bids for the above-mentioned procurement project was held at the BFAR Director's Office (D.O.) Conference Room, 3rd /F PCA Building, Elliptical Road, Diliman, Quezon City and and thru through video-conferencing via "Zoom" application. After ascertaining the existence of quorum, the meeting was called to order at 10:10 a.m. presided by Atty. Benjamin F.S. Tabios, Jr., Chairman of the Bids and Awards Committee (BAC).

The Chairman, before proceeding with the Opening of Bids, acknowledged the presence of the Members of the BAC, BAC Secretariat, member of Technical Working Group and COA Representative, present thru videoconferencing.

The BAC Chairman proceeded then with the opening of the Eligibility and Technical Envelope of the lone bidder namely, "Double J Agri Supply". The bid envelope is submitted on time, properly marked, signed and properly sealed.

In the preliminary evaluation using a non-discretionary pass or fail criteria, during the opening of the Legal and Technical envelopes submitted by "Double J Agri Supply", was declare as "PASSED" and eligible for the opening of the financial bid envelope, however NFCC is subject for verification and re-computation of the TWG.


During the opening of the financial bid envelope submitted by "Double J Agri Supply" their bid as read is in the amount of Two Million Thirty Two Thousand Pesos (P2,032,000.00).

After reading and determining the amount of bid as proposed by "Double J Agri Supply", the BAC declared its bid as a Single lowest bid as read for the said procurement project and will be subjected to detailed bid evaluation and post qualification process to be conducted by the Technical Working Group (TWG).

The Chairman instructed the BAC Secretariat that the copy of the opened bid envelopes should be forwarded to the TWG for detailed bid evaluation and post qualification.

There having no other bids to be read and clarifications to be made, the bid opening conference was adjourned at 11:00 AM.


